Selection Process

- Turn in a typed completed application & supporting documents
- Present a 1-3 minute Speech in front of the chapter at the April FFA meeting
 - o Answer a thought question if you are running for president
- Take a Knowledge Test
- Complete an Interview by a Committee
- Be Installed at the end of the year Chapter Banquet
- Students may hang campaign posters in the Ag department. Posters may be no larger than 11x 14 (a half poster board) and may be hung after April 3rd. They must be approved by an AST before being hung.

Qualifications

To participate in the Spring Branch FFA Chapter Officer program, officer candidates must meet all of the eligibility requirements:

- Must be a current FFA member, and have met the requirements to hold a Geenhand degree and be working towards a chapter degree
- Be enrolled in an agriculture course for **both** semesters the year following the election.
- Be familiar with the current Chapter Constitution & FFA Code of Ethics
- Show a genuine interest in FFA and its activities.
- Have not received OSS or DAEP within the current semester
- Complete all of the chapter officer selection process

Scoring

4 Scoring Divisions:

- Test- in order from the highest test score to the lowest test score (20% of the total score)
- **Interview** in order from most amount of points to least (50% of the total score)
 - o Questions, some of which will be created from your application answers
- Chapter Vote to be completed after presenting candidate speeches (30% of the total score)

Officer Placement

Students interested in running for the president position must indicate this on their application. Only a senior or a second year officer may become President, per our Constitution. The candidate with the highest score from those that indicated interest will become President. The remaining seniors and second year officer candidates will return to the general pool of names for the officer team. The remaining members with the highest overall scores from the remaining scoring divisions will serve as our 2022 - 2023 Spring Branch FFA Officer Team

Officers will be ranked highest to lowest based on their overall scores and the rank will determine their placement on the team from Vice President to Student Advisor.. Any ties will be broken with placing the student with the higher test score over the student(s) with a lower test score. If tie continues, then the tie breaker will go as follows: 1. Test score, 2. interview, 3. Application, 4. Popular vote

Mandatory Summer Required Activities Calendar

Officers must attend all monthly scheduled FFA officer meetings, FFA meetings and chapter sponsored activities throughout the school year. If you are unable to participate in all summer activities, do not run to be an officer. Should you make the team and you fail to attend summer activities, the result will be your immediate removal from the team.

Selection Process Timeline

March 30th 5:00-6:00 pm - Parent and incoming officer meeting - Mandatory

This meeting will allow parents and students to make sure that everyone understands the full commitments of being a Spring Branch FFA Officer

April 3rd by 4:00pm

- 1. **Application:** The application is available online bit.ly/3LN5KMh
- Students should download the application to their computer, type the information into the
 document, print one copy and return the completed application to the Advisor. Applications will be
 utilized as part of the interview process

- 3. **Handbook Acknowledgment Form:** This form must be <u>signed</u> by <u>both</u> the parent and the member and returned to the FFA Advisors. This is your formal acknowledgement of the commitment and responsibility of holding an office.
- 4. **FFA Code of Ethics Acknowledgement form:** This form must be <u>signed</u> by <u>both</u> the parent and the member and returned to the FFA Advisors. This is your formal acknowledgement of the ethical commitment and responsibility of holding an office.

April 4th starting at 3:30PM

 Practice Interview: We will also host a practice interview (not required). Please sign up with the link <u>bit.ly/3H68XQT</u> - No later than 4PM April 3rd

April 11th at 6:00PM

• Chapter vote and Speech: FFA Members must give a speech no more than 3 minutes declaring their intent to run for office. <u>Candidates must be in FFA Official Dress</u> and have already met the previous commitments. At the FFA Meeting the membership will vote.

*Students running for president will be asked a thought question

April 12th at 4:00PM

- Test: The test will be a 50-75 question test with multiple choice, true/false, and short answers
 covering FFA History, facts, and Parliamentary Procedure. Students should study the FFA
 Manual, SBFFA Ambassador Study Guide and the Parliamentary Procedure Guide. See the
 study guide posted on the chapter website. If you need a copy of the study material, you need to
 request this from the AST.
- Interviews for all candidates

Candidates will be interviewed by an *interview panel* of judges chosen by the advisors. Candidates must wear FFA Official Dress.

• Officer Installation at Chapter Banquet

Officers will be installed during the Chapter Banquet in May, at which their year of service will begin. New officers are responsible for helping to clean up and doing a dress rehearsal at 4:30PM

Spring Branch FFA Officer Demerit System

FFA Officers are the elite chosen few, therefore should be very aware of their choices and actions while in office. While in this leadership role, you will be watched by others, so to help maintain a dependable team with integrity, officers will be held accountable by this demerit system.

- ★ Officers are allowed 4 demerits, but once you have received your 5th demerit, you will be required to submit a resignation for the office that you hold.
- ★ Do not assume the Advisors know where you are. You must call as if you would be calling into work or make other arrangements. Text Messaging is acceptable, but make sure you receive a response, so you will know that we are acknowledging your request.

Reasons for Immediate Removal which may be a result of any of the following by level of severity as determined by the ASTs.

- Two or more unexcused absences from required Events
- Loss of use of AG Facility
- Proof or documentation of a MIP or Criminal offenses provided by an official, to the advisors.
- Ineligible for two grading periods.
- Excessive verbal and/or any amount of physical fighting.
- OSS or DAEP
- Failure to attend mandatory summer activities.
